# Annual Report of Immigrant Visa Applicants in the Family-sponsored and Employment-based preferences Registered at the National Visa Center as of November 1, 2023

Most prospective immigrant visa applicants qualify for immigrant status under U.S. law on the basis of family relationships or employer sponsorship. Entitlement to visa processing in these classes is established ordinarily through U.S. Citizenship and Immigration Services (USCIS) approval of a petition filed on the applicant's behalf by the sponsoring family member or employer. USCIS forwards the approved petitions for applicants who will be processed at an overseas U.S. embassy or consulate to the Department of State. Applicants in categories subject under law to a numerical limit are registered on the visa waiting list discussed below. Note that applications for adjustment of status under U.S. law (Immigration and Nationality Act (INA) Section 245) which are pending at USCIS Offices are not included in the tabulation of the immigrant waiting list data provided below. As such, the following figures ONLY reflect approved petitions which the Department of State has received, and do not include the significant number of applications held with the USCIS Offices.


Each case is assigned a priority date based on the filing date accorded to the petition; this is the applicant's place in line. When their priority date is within the *dates for filing* published each month in the Department of State's Visa Bulletin, the Department of State's National Visa Center (NVC) advises the applicant to pay fees and assemble and submit documents required for visa processing (i.e., become documentarily complete). Visa issuance within each numerically limited category is possible only when the applicant's priority date is within the applicable *final action dates*, also published in the *Visa Bulletin*. Eligible family-based and employment-based immigrant visa applicants are subject to overall worldwide annual numerical limits within their respective categories; in addition, INA 202 sets a per-country maximum on the number of family and employment-based visas which may be issued in a single year to applicants from any one country regardless of where they are processed. The totals in this report reflect applicants with approved petitions slated for overseas visa application at all stages of this process – those that are not yet documentarily complete, those that are documentarily complete and waiting for their priority date to become current, and those whose priority date is current and are waiting to be scheduled for an interview.

The following figures are compiled from the NVC report submitted to the Department on November 1, 2023, and show the number of immigrant visa applicants on the visa waiting list in the various preferences and subcategories subject to numerical limit. All figures reflect persons registered under each numerical limitation, i.e., the totals represent not only principal applicants or petition beneficiaries, but their spouses and children entitled to derivative status under INA Section 203(d) as well.

The Employment-based totals provided in this year's waiting list report are considerably higher than last year. This is in part due to the Employment-based annual limit, calculated based on the procedures established in INA Section 201(d), returning to baseline levels after record highs in the immediate post-pandemic years. Cases not processed under these lower annual limits have been retained at NVC and included in this year's report. 

# Immigrant Waiting List By Country

Immigrant visa issuances during fiscal year 2024 will be limited by the terms of INA Section 201 to no more than 226,000 in the family-sponsored preferences and approximately 161,000 in the employment-based preferences. (Visas for "Immediate Relatives" - i.e., spouses, unmarried children under the age of 21 years, and parents of U.S. citizens - are not subject to numerical limitation.)

It should by no means be assumed that once an applicant is registered, the case is continually included in the waiting list totals unless and until a visa is issued. Consular procedures mandate a regular culling of visa cases to remove from the count those unlikely to see further action, so that totals are not unreasonably inflated.

The ten countries with the highest number of waiting list registrants for both family and employment visas in FY 2024 are listed below; together these represent 74.9% of the total. This list includes all countries with at least 78,000 persons on the waiting list. INA Section 202 prescribes that visa issuances to nationals of any single country may not exceed seven percent during a fiscal year. This limit serves to avoid the potential monopolization of the annual limitation by applicants from only a few countries. That limitation is not a quota to which any particular country is entitled, however. For FY 2024 the per-country limit will be approximately 27,090.



## Family-sponsored Immigrant Waiting List by Country

This list includes all countries with at least 77,000 persons on the waiting list. (The per-country limit in INA 202 sets an annual maximum on the amount of Family preference visas which may be issued to applicants from any one country; the FY 2024 per-country limit will be 15,820.)



Applicants are being added to the waiting list in this category not only by the approval of new FIRST preference petitions, but also through automatic conversion of pending 2B applicants into FIRST preference upon the naturalization of the petitioner.

The overall decrease in total applicants in the FIRST preference could result in gradual advances in the worldwide final action date in the coming fiscal year. Only two countries, Mexico and Philippines, have FIRST preference final action dates which are earlier than the worldwide date. (NOTE: A Family 2B petition automatically converts to a Family FIRST petition if the petitioner naturalizes. However, Section 6 of the Child Status Protection Act of 2002, Pub. L. 107-208, provides relief for Family 2B applicants who would be disadvantaged by a conversion to Family FIRST status due to a less favorable Family FIRST final action date.)

# Family SECOND Preference:

The total Family SECOND preference waiting list figure is 723,622. Of these, 337,958 (46.7%) are spouses and children of permanent residents of the United States (the 2A class), and 385,664 (53.3%) are adult unmarried sons/daughters of permanent residents (the 2B class). The Family SECOND preference represents 19.2% of the total Family preference waiting list. It will receive 114,200 visa numbers for FY 2024, just over half of the 226,000 family preference total; 77% of SECOND preference numbers are provided to 2A applicants, while the remaining 23% go to the 2B class.

Upon naturalization of the petitioner, a pending 2A case is usually converted automatically into the "Immediate Relative" visa category, which is not subject to numerical limit and therefore has no visa waiting period. If 2A children applicants are over 21 years of age once the petitioner naturalizes, their case is usually converted into the Family FIRST category. As a result, the number of cases being processed in the "Immediate Relative" or Family FIRST categories may increase and partially offset new F2A filings.

**2B**: Visa numbers for this class of adult sons and daughters will be approximately 26,260 during FY 2024. The top ten countries with the highest 2B waiting list totals are:

#### Family THIRD Preference:

The annual visa limit is 23,400. Two oversubscribed countries (Mexico and Philippines) have sufficiently heavy demand in this preference to require a final action date substantially earlier than the worldwide date. The top ten countries with the highest F3 waiting list totals are:

# Family FOURTH Preference:

Applicants registered in the Family FOURTH preference total 2,199,512. Annual visa issuances are limited to 65,000. The waiting period for the Family FOURTH preference is longer than any other category because the demand significantly exceeds the number of available visas. The countries listed below have the largest number of FOURTH preference applicants:

The waiting period in this preference is now over sixteen years for countries of most favorable visa availability and even longer for some oversubscribed countries (notably Mexico, India, and Philippines).


# **Employment-based Immigrant Waiting List by Country**

It is important to note that normally about eighty-five percent of all Employment preference immigrants are processed as adjustment of status cases at USCIS offices. Cases pending with USCIS are not counted in the consular waiting list tally presented below. Therefore, in several Employment categories the waiting list totals being provided below significantly understate true immigrant demand. The Employment waiting list counts not only prospective workers, but also their spouses and children entitled under the law to derivative preference status.

The five countries with the highest number of Employment-based waiting list registrants are listed below; together these represent 65.2% of the total. This list includes all countries with at least 9,500 persons on the waiting list. (INA 202 sets an annual maximum per country limit on the amount of Employment preference visas which may be issued to applicants from any one country; the FY 2024 per-country limit will be approximately 11,270.)



Sufficiently heavy demand in the Employment Third Preference category has necessitated the establishment of a final action date for all countries. Two oversubscribed countries (China-mainland born and India) have enough demand to require earlier final action dates. In the Third "Other Worker" Preference category, demand has been sufficient to necessitate a worldwide final action date, while China-mainland born, India, and Philippines require earlier final action dates.

The Fifth Preference (C5, I5, R5, and T5) categories are "current" at present for all countries except China and India. The EB-5 Reform and Integrity Act of 2022 reserved Employment Fifth Preference visas for qualified immigrants who invest in rural areas, high unemployment areas, and infrastructure projects. These set-aside categories are "current" at present for all countries. State and USCIS anticipate issuing these visas in the coming fiscal year, and final action dates may be set if demand for any of these categories exceeds the annual limits.
